Whereas, GIFT has announced its admission for PGD-GST course for the academic year 2020-21 (referPGD-GSTProspectus 2020signed by both the parties as the annexure to this MOU)

Whereas, PGD-GST Course is of one-year duration and will be imparted through training programme of 120 hours covering theoretical and practical aspects of GST which consist of five papers and the medium of instruction and examination will be English. The syllabus of PGD-GST comprises mainly of two components, General Education and Skill, in which 30 per cent consist of General Education and 70 per cent consist Skill based education The training will be conducted in class room and online mode.

Whereas, the second party has mooted a skill based training initiative of UGC guidelines and wish to sign a MoU with GIFT for the conduct of PGD-GST course at its college.

- 1. Whereas, the total fees of the PGD-GST course per student is Rs.20230 out of which a fee concession of Rs.4760 (third instalment fees) as envisaged in the Clause 2.7 of the prospectus 2020 is applicable to the students who joins through the collegefor the academic year 2020-21.
- 2. Whereas, for complying the formalities of UGC guidelines, if necessary, the college responsibility is to get the approval of PGD-GST syllabus as envisaged in the prospectus 2020 from the academic council of Kerala University and/or NSQF of UGC as the case may be.
- 3. Whereas, the college shall add one or many modules as 'add-on module(s)' along with the GIFT PGD-GST course syllabus, if needed, for imparting practical/lab based skill trainings on Computer Accounting Packages like Tally etc. For this the college shall hire necessary faculty members and arrange the required computer lab at college at their own cost and effort. For meeting such additional cost, necessary fee can be collected separately from the student by the College.

Whereas, it is the responsibility of the college to ensure the enrollment of students to this course, remit the required fees to GIFT and comply all the procedures for the students as envisaged in the prospectus.

- 5. Whereas, GIFT shall admit students, provide necessary study material, conduct training programmes, evaluate the assignment of students, conduct examination, issue training and PGD-GST certificates as per the terms and conditions given in the prospectus.
- 6. Whereas, the college retains the right and responsibility for admission, attendance, infrastructure and all other administrative activities of the conduct of course.
- 7. Whereas, the college shall enroll a minimum of 40 students for the academic year 2020-21 for full faculty support from GIFT (i.e. 120 hours training programme). If in any case less than 40 students enrolled in an academic year 2020-21, then the following slab system shall be adopted
 - a. If students enrolled is less than 20 numbers, then GTFT faculty support shall be for 40 hours and the balance 80 hours the college shall engage faculty members at their own cost
 - b. If students enrolled is more than 20 numbers and less than 30 numbers, then GIFT faculty support shall be for 60 hours and the balance 60 hours the college shall engage faculty members at their own cost
 - c. If students enrolled is more than 30 numbers and less than 40 numbers, then GIFT faculty support shall be for 90 hours and the balance 30 hours the college shall engage faculty members at their own cost
 - d. If students enrolled is 40 numbers or above, then the GIFT faculty support shall be for 120 hours
- 8. Whereas, for the internship programme for the students of the PGD-GST course, GIFT shall assistant the College for identifying the firms/organizations/corporates for carrying out their internship.

Whereas, for the placement assistance for the successfully passed students of PGD-GST, GIFT shall assist the College in identifying the prospective employers through placement drive.
